Citing TREN Documents

Formats Recommended for APA, MLA, and Turabian Styles

Introduction

Citing TREN documents in common bibliographic styles can prove to be a challenging task for at least two reasons. First, the APA, MLA, and Turabian manuals do not provide specific guidelines for citing TREN documents as they do for sources from other distribution services, such as ERIC, NTIS, and UMI. Second, TREN documents can be obtained in several formats through a variety of means, which can lead to divergent requirements for citation.

I have drafted the sample citations below to aid researchers in observing prevailing style conventions when citing TREN documents. Since the latest revision of Turabian's *Manual* was published in 1996, I have taken the liberty of following the more current provisions of *The Chicago Manual of Style*, 15th edition (2003), in Turabian citations that include electronic retrieval information.

No doubt some scholars, especially those who teach research methods, will apply the principles of a given style manual somewhat differently than I. Nevertheless, I recommend these formats as a baseline from which local adaptations can be made.
